

THE SERVICE

The Pharmacotherapy Support
Program assists people who are on
Methadone, Suboxone or other
replacement therapies to better
access residential alcohol and drug
treatment.

This Program provides holistic care and support to people receiving a replacement therapy for their substance use issues, their families, support people and other service providers.

The primary aim of this program is to support people to better stabilise on their replacement therapy so they can enter a rehabilitation program or receive support after they have completed a rehabilitation program.

As part of the program, with your permission, we will work with your prescriber, pharmacist, support person(s) and other service providers.

THE SERVICE

The Pharmacotherapy Support
Program Nurse will have regular
contact with you to assist you to enter
a rehabilitation program or transition
into the community after completing a
rehabilitation program.

The Nurse can provide support in your own home (if safe), or an agreed environment that is safe and easily accessible. For example, a community health centre.

Support can be provided in person, via the telephone or secure webbased contact.

The Nurse can provide information and education to you, your support person(s) and service providers.

ELIGIBILITY

You live in the ACT.

18 years old and over.

You are currently participating in a Methadone, Suboxone or other replacement therapy program and would like some help to access residential or day rehabilitaiton programs.

You need further support to stabilise your replacement therapy.

You have recently completed a residential rehabilitation program and would like further support in the community.

You are willing to engage in a support program.
